#### Adriana De Oro Osorio - Strategic Planning Associate, Global Humanitarian Lab

With a master's in Innovation for Sustainable International Development, Adriana transitioned from the Innovation Unit at UNHCR to the Global Humanitarian Lab (GHL) where she supports and facilitates the deployment of projects in the field. Passionate about crowd & group ideation, she is co-creator of the Geneva Global Goals Innovation Day (G3iD) association.

#### Alejandro Morlachetti - UNICEF consultant and child rights expert

Alejandro Morlachetti holds a Master of Laws degree (LL.M) from Columbia University and a Law degree from the School of Law of the University of Buenos Aires. Since 1998 he has been working as an independent consultant for several international organizations, including: UNICEF, IOM, WHO, UNFPA, ILO, FAO, ECLAC, and the OHCRH. He has been an advisor of several governments on how to integrate human rights and gender into national public policies and legislation - in particular related to children rights. Currently, he is preparing draft version of the Joint General Comment on Children in the Context of Migration.





#### Alessio Fasulo - Project Coordinator, Save the Children

The Italian Programme operates in 7 District Regions. Previously he has worked for MSF Belgium – Missione Italia, and EMERGEN-CY NGO Surgical Centre in Goderich Freetown, Sierra Leone.

#### Andrew Brooks - Regional Advisor for Child Protection for West and Central Africa, UNICEF

Andrew has served as UNICEF Regional Advisor for Child Protection for West and Central Africa, Dakar, Senegal since August 2013. Before joining UNICEF, he worked in the UK as a Social Worker and Team Manager in Nottingham. Andrew Brooks is a UK national. He holds a Masters in Social Work, Nottingham University and a Master's in English Literature, Cambridge University.



#### Anna Cristina D'Addio - Senior Policy Analyst, UNESCO

Anna, Economist by background, is a Senior Policy Analyst in the Global Education Monitoring Report team (UNESCO). Previously at the OECD, Anna worked on several issues ranging from financial education, the intergenerational transmission of disadvantages, to social protection issues, with an emphasis on the role of policies. Mr. Dulay oversees and coordinates welfare services for overseas Filipino workers, rescue and repatriation, conciliation and counselling services, skills training, among others.



#### Balázs Lehel - Head of Office, IOM Budapest

Balázs received his MA in international relations from the Corvinus University of Budapest. During his university studies he spent 11 months as an intern in New York, at the Headquarters of the International Rescue Committee (IRC), a non-governmental, international relief and development non-profit organization. He started working for the International Organization for Migration (IOM) in 2006. Since then, he has been involved in the development and implementation of several regional and national projects, ranging from assisted voluntary return and reintegration to resettlement, public health safety, awareness raising, education, integration and counter-trafficking. #### **Beata Godenzi - Programs Director, Terre des Hommes**

Beata Godenzi Rasmussen is Programs Director and Chair of the Operations Committee at Terre des Hommes Foundation. She studied political science at the University of Lausanne and comparative research on development at the HEHESS in Paris. After her studies, she worked in research and in 1996 she joined, as a JPO, UNFPA in Dakar, Senegal. Beata was Head of the Projects Commission at Swiss Solidarity and later worked at the Federal Department of Foreign Affairs at the Swiss Agency for Development and Cooperation (SDC). From 2009 to 2014, she was the Head of the newly created Global Program Migration and Development (GPMD).

#### Ben Lewis - Advocacy Coordinator, International Detention Coalition

Ben is an international human rights lawyer with extensive policy advocacy experience working with refugee, asylum seeker and migrant populations in the United States, Latin America and East Africa. As Advocacy Coordinator, Ben aligns the IDC's global, regional and domestic advocacy engagement around the IDC's three Strategic Priorities and is responsible for coordinating government engagement around alternatives to detention. Ben leads the IDC's UN and intergovernmental advocacy work, and provides technical support to IDC members globally on the international human rights framework, developing and implementing advocacy strategies, and strategic litigation. Ben graduated in International and Comparative Law, University of San Francisco School of Law.





#### Beris Gwynn - Founder and Managing Director, Incitare

Beris began her career with the Australian Department of Foreign Affairs serving in Vietnam, Poland, Mexico and Nauru. In 1989, she joined the Australian International Development Agency, leaving to take up a senior position with World Vision Australia in 1994. Between 2000 and 2006, she served as Executive Director of the Brisbane-based Foundation for Development Cooperation. Appointments in Stockholm and Geneva followed, with the Global Water Partnership Organisation (2006-8) and World Vision International (2008-15) respectively. At the end of January 2016, Beris launched an open platform (Incitare) to support greater engagement with strategic foresight/futures thinking and the brokering of innovative and accountable multi-stakeholder partnerships to accelerate achievement of the SDGs.

#### Bernard Gastaud - Committee Member, UN Committee on the Rights of the Child

Bernard is one of 18 independent experts with recognized competence in the field of human rights elected for a second term commencing in 2015. Bernard is from Monaco and comes to the position with a wealth of expreince include experience as the Legal Adviser for legal and international affairs to the Department of External Relations (Ministry of Foreign Affairs of the Principality of Monaco) and as a Member of the Committee of legal advisers on public international law (CADHI) Council of Europe He is a member of Member of the World Association of Children's Friends (AMADE).



#### Chris Derksen Hiebert - Director, Policy and External Relations, World Vision

Chris is Director of Policy and External Relations in the Advocacy and External Engagement team of World Vision International. In this role, Chris provides overall guidance for the team's public policy development, and leads the development and implementation of the organization's engagement strategies at major global forums, and processes such as Agenda 2030, the G7 and G20, and the UNGA. Chris has been a leader in child focused advocacy with World Vision for more than fifteen years, having served as Senior Advisor, Peacebuilding, and Director of Advocacy for World Vision Canada prior to taking on his current role in 2011. Chris is based in Heidelberg, Canada.

#### **Christian Skoog - Representative of UNICEF Mexico**

Christian has been the Representative in Mexico since September 2016, and previously in Guatemala and Mauritania, as well as Deputy Representative in Haiti. Christian joined UNICEF in Geneva in 2002, as responsible for inter-agency coordination on humanitarian policy and response. From 1996 through to 2002, Christian was working with the UN Office for the Coordination of Humanitarian Affairs (OCHA) with postings in Geneva, Afghanistan and Maluku (Indonesia). He worked on all aspects of humanitarian programs, including operations, negotiations with authorities, donor and media relations, fundraising, inter-agency collaboration and management. He began his UN career in 1993 in the Population Division with a focus on researching international migration.





#### Chryssoula Botsi - Medical doctor, Hellenic Centre for Disease Control and Prevention (KEELPNO)

Chryssoula Botsi is a medical doctor, specialized in pulmonology, tuberculosis and HIV/AIDS. She works within the unit of infectious diseases at the university hospital A. Sygros in Athens. She is also a doctor working with the Hellenic Centre for Disease Control and Prevention (KEELPNO). She is a consultant for the President's office in KEELPNO on HIV, migration, trafficking and SGBV. She is also a consultant to the Minister of Migration in Greece on health and trafficking. She is also the scientific coordinator for the PHILOS project funded by AMIF. She graduated from Panteion University and completed a post-graduate course on psychology and mass media.



Dan Tyler is the Norwegian Refugee Council's Regional Protection and Advocacy Adviser for Europe and Asia. Between 2010 and 2014, Dan was based in NRC's Kabul and Islamabad offices and, during 2016, was part of NRC's response team in Greece, where he was based on the island of Chios. Dan has written extensively on humanitarian and protection challenges faced by internally displaced persons and protracted refugees, in 2015 co-authoring a report on urban displaced women and girls in Afghanistan. Dan has worked with international humanitarian organisations across Africa, Middle East and Asia.





#### Daniel Pop – Senior Team Manager for the Education Support Program, Open Societies Foundation

Daniel is a political economist by training, and earned his PhD from Central European University. In 2008, Daniel joined ESP where he leads on efforts to build networks of commitment around the need of education stakeholders' meaningful engagement into educational governance at all levels including new forms of civil activism. Daniel has initiated and led several research and fellowship programs and publishes on the theme of marketization of social services delivery.



#### Daniela Reale - Child Protection and Children on the Move Lead, Save the Children

Daniela is Save the Children Lead on Children on the Move. Daniela has over 15 years' experience working on child protection on child migration and trafficking, supporting both direct programmes globally and leading on policy and advocacy on children on the move and on child exploitation, including child labour and trafficking. She pioneered the Children on the Move framework, successfully advocating for this approach to be adopted in a variety of contexts. She holds a degree in International Political Economy from the London School of Economics and has long-standing experience in the fields of child protection, exploitation, trafficking and related issues.

#### Dionne Akiyama - Protection Coordinator, International Rescue Committee

Dionne has served as the Protection Coordinator for IRC Balkans program since May 2016. Currently, Dionne leads the IRC's programming and collaboration with partners to provide integrated protection, legal aid, and psychosocial support to vulnerable refugees and migrants in the Balkans. Dionne has worked in the field of protection for over 10 years, specializing in psychosocial support and protection of women and children. Previously, Dionne supported humanitarian responses in Sierra Leone and the Philippines, field research on strengthening child protection systems in Haiti, and community-based child protection and psychosocial support in the USA and Indonesia. Dionne holds a Master's in Social Work from Columbia University.





#### Elinor Raikes - Regional Director for Europe and North Africa, International Rescue Committee

In her current role, Elinor oversees IRC's programs and partnerships across Europe (with country offices located in Germany, Serbia and, Greece) as well as programs in Libya. She worked as an independent consultant, mainly for DFID, in 2014-15. She was previously with the IRC for six years and during that time worked for many years in DR Congo as well as in Chad, Afghanistan and Zimbabwe. Prior to the IRC, Elinor worked for Save the Children. She went to the University of Edinburgh (undergraduate in French & Philosophy) and University of London (postgraduate Masters in Violence, Conflict and Development).

#### **Ellene Sana - Executive Director, Center for Migrant Advocacy**

The Center for Migrant Advocacy is a Philippine-based non-governmental organization that works for the rights and welfare of Filipino migrant workers and their families through policy advocacy and facilitating assistance to distressed migrants. Ellen's areas of competency are advocacy and lobby work in local, national, regional and international forums, and training and capacity building on migrant rights. Ellen Serves as CMA's principal resource person and representative on migration-related forums and activities in the Philippines and abroad.





#### François Crépeau - UN Special Rapporteur on the human rights of migrants

François Crépeau is the United Nations Special Rapporteur on the Human Rights of Migrants. He holds the Hans & Tamar Oppenheimer Chair in Public International Law at the Faculty of Law of McGill University, where he teaches International Migration Law, International Human Rights Law, Public International Law and Canadian Constitutional Law. His research focuses on migration control mechanisms, the rights of migrants, the migration-security nexus and the Rule of Law as applied to globalisation. He holds degrees from McGill University, Bordeaux University, Paris II University Panthéon-Assas and Paris I University Panthéon-Sorbonne (PhD).

#### Frank Laczko - Director of IOM's Data Analysis Centre, Berlin

Frank is Director of IOM's Data Analysis Centre in Berlin. The Centre recently published two data briefs about data and the migration of children. He is currently preparing IOM's third global report on migrant fatalities "Fatal Journeys". He has over twenty years of experience in the migration field and has held posts with IOM in Budapest, Vienna and Geneva.





#### Friedrich Affolter – Education Expert for Risk-Informed, UNICEF

Friedrich Affolter is an Education Expert for Risk-Informed Programming at the Education-in-Emergency and Early Childhood Development Units in UNICEF NY Programme Division. Until June 2016, he served as the manager of UNICEF's Peacebuilding, Education and Advocacy Programme (PBEA), which designed education programmes that contribute to the mitigation of drivers of conflict in 14 fragile and post-conflict countries. Earlier UN assignments include Sudan, South Africa, Angola and Afghanistan. Friedrich holds a Masters and a Doctorate Degree from the Center for International Education of the University of Massachusetts at Amherst.

#### **George Gabriel - Founder and Project Lead, Safe Passage**

George is the founder and Project Lead for Safe Passage, a new and multi award winning programme that works to open safe and legal routes for refugees. George worked for 8 years as a community organiser on a wide issues ranging from getting misogyny recognised as a hate crime and tackling destitution, to breaking the Living Wage into the retail sector and creating a global Living Wage initiative. Over 1,110 refugee children have travelled through safe and legal routes Safe Passage has opened, George has also driven work to build 96 refugee welcome groups across Britain, introduce community sponsorship, and grow the UK's resettlement commitment.





#### **Grant Mitchell - Director, International Detention Coalition**

Grant Mitchell is a social anthropologist in international migration. Grant has extensive experience in international asylum and immigration detention policy, including working on the development and implementation of alternatives to immigration detention and case management models. Grant sits on the tripartite Asia Forced Migration Dialogue, is a member of the US government's Department of Homeland Security (DHS)-NGO Working Group and the Family Case Management Reference Committee and is a founding member of the Asia Pacific Refugee Rights Network. He is currently a PhD candidate with Swinburne University researching government engagement by civil society on Border, Migration and Sovereignty in the context of immigration detention.

#### Ignacio Packer - Secretary General, Terre des Hommes International Federation

Ignacio Packer is Secretary General of the Terre des Hommes International Federation. He is an international expert on child rights and social issues. He gives leadership to the overall development of Terre des Hommes and its organizational culture. He was previously Programme Director at the Terre des Hommes Foundation. He also worked for the European Bank for Latin America, KPMG, Médecins Sans Frontières, the European Association for Development and Health and for the Swiss Tropical Institute. On 30 June 2017, Ignacio will be leaving Terre des Hommes after 17 years and six year as global CEO.



#### Irene de Lorenzo-Cáceres Cantero - Advocacy and Policy Specialist, UNICEF



Irene holds her position in UNICEF's Division of Private Fundraising and Partnerships in Geneva, where she coordinates advocacy on refugee and migrant children by UNICEF National Committees. Previously based in New York, she: worked on UNICEF's advocacy on SDGs; supported UNICEF Country and Regional Offices in the development of advocacy strategies; and provided policy support on migration and development issues. Irene has also worked as consultant for Human Rights Watch on the US-Mexico border focusing on gender-based violence and has volunteered with several community-based organizations working with migrant women and youth. Irene holds a Double Master's Degree in European Studies from LSE and Sciences Po Paris.

# Irene Pastorino Olmi - Diplomat, Unit for Migration Policy, Directorate General for Italian Citizens Abroad and Migration Policy

Irene Pastorino Olmi is a young diplomat with a legal background. She has been working since 2016 at the Italian Ministry of Foreign Affairs and International Cooperation, Directorate General for Italian Citizens Abroad and Migration Policy, Unit for Migration Policy. The Unit is also responsible for negotiation of the Global Compact for Safe, Orderly and Regular Migration and the Global Compact on refugees.



#### Irina Todorova – Senior Regional Specialist on Counter-Trafficking and Assistance to Vulnerable Migrants, IOM

Irina serves her position in IOM's Regional Office in Brussels where she has been working since October 2013. Irina is responsible for analysing regional thematic trends, supporting liaison with the EU Institutions and EU Member States, and she leads human trafficking prevention and protection programmes in Europe. Irina has worked as a counter-trafficking and migrant rights practitioner for over 13 years, particularly in Europe and Central Asia. In addition to her expertise in counter-trafficking, Ms. Todorova has several years of experience working for the protection of children in a migration context.

#### Jacqueline Bhabha - Professor of the Practice of Health and Human Rights, Harvard Chan School of Public Health

Jacqueline is Director of Research at the Harvard FXB Center for Health and Human Rights, the Jeremiah Smith Jr. Lecturer in Law at Harvard Law School, and an Adjunct Lecturer in Public Policy at the Harvard Kennedy School. She received a first class honors degree and a M.Sc. from Oxford University, and a J.D. from the College of Law in London. From 1997 to 2001 she directed the Human Rights Program at the University of Chicago. Prior to 1997, she was a practicing human rights lawyer in London and at the European Court of Human Rights in Strasbourg. She has published extensively on issues of transnational child migration, refugee protection, children's rights and citizenship. She is the editor of Children Without A State (2011), author of Child Migration and Human Rights in a Global Age (, Princeton University Press, 2014), and the editor of Human Rights and Adolescence (UPenn Press, 2014). She serves on the board of the Scholars at Risk Network, the World Peace Foundation and the Journal of Refugee Studies.





#### Jem Stevens - Europe Regional Coordinator, International Detention Coalition

Jem has been working in the field of human rights research and practice for a number of years, with a focus on human rights in places of detention. She previously worked for the Association for the Prevention of Torture (APT) both as a research consultant and as Asia-Pacific Programme Officer. Prior to that, Jem was Human Rights Officer with the OHCHR in Nepal, where she was involved in monitoring places of detention and investigating conflict-related human rights violations including torture and disappearances. Jem has a bachelor's degree in law and French law and a master's degree in human rights and democratization.

#### Jens Matthes - Senior Advisor on Advocacy and Policy, UNICEF

Jens is a Senior Advisor on Advocacy and Policy in UNICEF, where he works on global policy issues affecting children, advocacy planning and political economy analysis. Jens has covered migration issued for over 20 years, working as a child protection expert in Rwanda, Sudan, Bosnia, and Pakistan, and later as UNICEF's Regional Advisor on advocacy in high income countries. Most recently he led the team producing the UNICEF report 'A child is a child: Protecting children on the move from violence, abuse and exploitation'. Jens holds a master's degree in law from the University of Bonn and was admitted to bar in Berlin.





# John K. Bingham – Head of Policy and Coordinator of the civil society activities of the Global Forum on Migration and Development, International Catholic Migration Commission

John, a lawyer by profession, he joined ICMC in 2005. Since 2010, the governments of Mexico, Switzerland, Mauritius, Sweden, Turkey and later Bangladesh have asked ICMC to take a leading role in organizing civil activities in and around the GFMD, chaired respectively by each government through 2016. In 2013, at the request of a diversity of civil society organizations worldwide, the Office of the President of the UN General Assembly designated him Coordinator of civil society participation in the High-Level Dialogue on International Migration and Development that the General Assembly organized that year.

#### Joshua Hofert - Member, Presidential Board, Terre des Hommes Germany

Joshua Hofert is a member of the Presidential Board of terre des hommes Germany. While overseeing the overall strategy of the child rights organization in Germany and 30 countries in Asia, the Middle East, Africa and Latin America, he has focused on issues related to children's rights and the environment, migration and development, as well as the participation and empowerment of children and youth. Connected to his studies in international politics, Joshua has researched and worked for United Nations Volunteers (UNV/UNDP) and instructed seminars on international development and children's rights at the University of Potsdam, Germany.

Julia Hahn is a freelance multimedia journalist and moderator based in Berlin. She works as a news anchor, editor and Turkey correspondent with DW, Germany's international broadcaster. #### Karen Whiting - Senior Advisor, Division of International Protection, UNHCR

Karen Whiting is the Senior Advisor (Child Protection and Youth) in UNHCR's Division of International Protection in Geneva. The Child Protection and Youth Unit provides support to UNHCR field operations and works to build institutional capacity to deliver quality child protection and youth programming. Prior to her posting in UNHCR Headquarters, Ms. Whiting worked with UNHCR in Sri Lanka, the Democratic Republic of Congo, Jordan, Turkey and in the Europe Bureau in Brussels. She holds a law degree from McGill University in Canada.



#### Katharina Lumpp - Representative of UNHCR Germany

After her law studies in Germany, Katharina began working for UNHCR in Brussels and Bonn, followed by two assignments in Afghanistan and Geneva. In 2006, she was appointed Deputy Regional Representative for Protection in Egypt and in 2010 for the UNHCR Regional Office for Southern Europe. #### Kirsten Di Martino - Country Coordinator for the Refugee and Migrant Response in Germany, UNICEF

Kirsten Di Martino is UNICEF Country Coordinator for the Refugee and Migrant Response in Germany. She is an expert in children's rights and child protection, with extensive expertise on violence against children, child trafficking, child justice, and refugee/migrant children. She has worked with UNICEF in Kosovo, Moldova, China, Lao PDR and Germany as well as with Defence for Children International, the International Social Service, the European Commission, and the UN Office of the High Commissioner for Human Rights. She holds a post graduate degree in International Human Rights Law (LL.M) from the University of Essex, UK.

#### Kristina Uzelac - Reporting and Information Officer, IOM

Kristina works as a Displacement Tracking Matrix (DTM) Reporting and Information Officer in IOM's Regional Office in Vienna focusing on collection of data related to the ongoing migration flows to Europe through the Mediterranean. She likewise coordinates Advocacy and Policy Development for the ISS network, focusing on child rights initiatives such as alternative care, children on the move, adoption, and international surrogacy in the UN arena and with regional bodies. She has recently undertaken evaluation missions to Cambodia, Cote d'Ivoire, Ghana, Morocco and Viet Nam.

#### Michela Macchiavello - Specialist for the Assistance of Vulnerable Migrants, IOM

Michela works as a Specialist for the Assistance of Vulnerable Migrants for IOM, in Geneva. She coordinates IOM's efforts on trafficking and exploitation in times of crisis and manages the Global Assistance Fund to assist vulnerable migrants worldwide. Before this, Michela worked on: counter- trafficking and Integrated Border Management issues in the Caribbean; the training of peace support personnel for Legon University in Ghana; refugees' issues in Uganda and as a Research Associate for the Refugees Studies Centre, University of Oxford. #### Michele Klein Solomon - Senior Policy Advisor to the Director General, IOM

This includes improving ways of protecting migrants and children from harm, notably by learning how they (and their communities) protect themselves from harm.





#### Moussa Harouna Sambo - Head of Mobility Programme, African Movement of Working Children and Youth

With the support of Caritas, Moussa trained in Niamey, Niger to become an apprentice carpenter. In 1998, he helped create an organisation for children and young workers in Niger and completed a training in participatory action research. In 2003, he accompanied groups of children and young workers in Niger. In 2006, as a member of AMWCY, he completed a training course on early migration in Dakar. Since 2007, he has been coordinating the regional program of AMWCY on the mobility of children.

#### Nahlah Ayed - Foreign Correspondent, Canadian Broadcasting Corporation

Nahlah Ayed is a London-based foreign correspondent for CBC. She spent nearly a decade in the Middle East, spanning the conflicts in Iraq, Lebanon and Gaza, all the way to the Arab spring. Her work has been repeatedly recognized in Canada and abroad, including by a UK Foreign Press Association award, and most recently, a Canadian Association of Journalists photojournalism award for her work on board a ship that rescues asylum seekers at sea. In 2012, Ayed published a book on refugeehood that also included her family's story. A Thousand Farewells, was a finalist for the Canadian Governor General's Literary Awards.





#### Niccolò Gargaglia - Child Protection Deputy Lead for Search & Rescue Response, Save the Children

Niccolò has been working for Save the Children (SC) Italy for three years, both as a child participation expert and child protection officer. He developed specific child participation methodologies, tested and then brought to scale in SC Italy's domestic programmes. Niccolò has been particularly involved in SC Italy's response to migration and refugee arrivals to Italy and in child protection programmes in transit areas. #### Pia Oberoi - Advisor on Migration and Human Rights, UN Office of the High Commissioner for Human Rights

Over the years at Terre des Hommes, Vincent worked as Coordinator of the Destination Unknown global campaign for TDHIF and Regional Child Protection Advisor for the Middle East and North Africa. In 2006, Vincent created the Regional Office of TDH for Central and South-Eastern Europe. For the past 15 years, he has been working in the field of transnational child protection issues within Europe and with neighbouring countries. He also worked as a journalist and international freelance reporter in countries in crisis (Balkans, Central Africa).

#### Vivienne Chew - Asia Pacific Regional Co-ordinator, International Detention Coalition

Vivienne is the Asia Pacific Regional Co-ordinator for the IDC, based in Kuala Lumpur Malaysia. She possesses over eight years of experience working with refugees and asylum seekers, predominantly in countries of first asylum. Currently, she is the Chair of the Asia Pacific Refugee Rights Network's (APRRN) Immigration Detention Working Group. She successfully established and managed legal aid programs for urban refugees and asylum seekers in Thailand and Tanzania. Vivienne has a law degree from the University of Cardiff, Wales, and a Masters in International Human Rights from the Josef Korbel School of International Studies, University of Denver. She is a qualified lawyer in England and Wales.





#### Yoomi Renström - Mayor of Ovanåker municipality, Sweden

Yoomi is Mayor of the Municipality of Ovanåker (Sweden). She is a graduate of the University of Uppsala, where she studied Literature, Psychology, and Information and Communication. She pursued her studies at the University of Falun, where she received Headmaster education. Before becoming a politician, she worked with disabled people both as member of the staff and later as a manager. She is member of the International Committee of SALAR, the Swedish Association of Local Authorities and Regions and also a member of the Congress of the European Council, CLRAE. Yoomi has been a member of the Committee of the Regions since 2007.



#### Abdulkarim Albrem - Spokesperson for youth group

Abdulkari is a 22-year old volunteer youth advocate. He was studying economics in Aleppo, when the war forced him to flee. He arrived in Germany and applied for asylum. After living in a reception center for almost a year, now he holds a temporary residence permit. He has been the spokesperson for his youth group since the spring of 2016. In this position, he raises awareness on the challenges refugees face, advocates for effective solutions in the protection of refugee children and youth, and calls on stakeholders to take meaningful action and involve the voices of youth in decision making processes that affect them.

#### Bahajt Alturjman - Singer-songwriter & Co-founder, LIBICO

Born in Libya, Bahjat is a 21-year-old singer-songwriter based in Malta with an interest in non-governmental organizations. Be it coaching, organizing or performing, he often participates in events that deal with youth integration. Bahjat is a strong believer in being able to feel home wherever you go. Having migrated to Malta at the age of 15, he understands the importance of being able to grow in an environment that allows you to be who you are. Furthermore, he is one of the founders of LIBICO, a Libyan NGO which aims to bring about the integration and empowerment of Libyans in Malta.





#### **Carl Kristiansson - Leader, One Third**

Carl is currently studying Sustainable Development and Geography at the University of St. Andrews in Scotland. Carl is also leading a youth organisation based in Sweden called One Third, which has the aim to make the voices of youth heard and valued, particularly in the context of migration and development. This summer, Carl is interning with Terre des hommes Hungary. Carl is passionate about meeting new people and sharing ideas and visions for a sustainable world. He is also a passionate recreational football player and enjoys hiking in the Swedish and Scottish mountains.

#### Elda Haziri - Volunteer with child rights NGOs

Elda is a 22-year old girl from Kosovo. She is currently in her last year of studies in social work. She was a refugee in Macedonia for three months during the war in Kosovo. She does a lot of voluntary work in different NGOs especially with children in Kosovo. Since Kosovo has a high level of migration, she is very interested in this topic and has learnt a lot during her Internship at the Center for Social Work.





#### Farah Abdi - Blogger, author and human rights activist

Farah Abdi is a Somali refugee and award-winning blogger. Farah arrived in Malta from Libya by boat in 2012, fleeing fear of persecution. Farah is author of the autobiography 'Never Arrive' and a human rights activist. Farah is also the recipient of the International Bremen Peace Award by the German NGO, Stiftung die schwelle, and the Queen of England award for young leaders. Farah says: "I have been told many times by family, friends, colleagues and strangers; that I am a black, African, refugee, Muslim, trans woman; that I am outside the norms accepted by society."

#### Hamza Ibrahim - Vice-President, Unaccompanied Minors Federation

Hamza is a 25-year-old of Somali descent. He moved to Sweden almost six years ago as an unaccompanied minor asylum seeker. After leaving Somalia, he attended high school in Sweden and is currently pursuing his bachelor's degree in political science at Malmö University. Hamza has worked as a volunteer for many organisations, such as Save the Children Sweden, the Red Cross, the National Council of Swedish Youth Organisations and with Somali migrant communities in Svalöv and Malmö. Since May 2016, Hamza has also served as Vice-President of the Unaccompanied Minors Federation, which is run by unaccompanied youth from different countries.





#### Khady Diop - Member, African Movement of Working Children and Youth

Khady was born in 1992 in Pikine, Senegal. The African Movement of Working Children and Youth (AMWCY) interested her, which is why she joined the movement. Initially, she was trained in sewing and beading. Later, she attended literacy classes organized by MAEJT and received training on the rights of children and young workers. She has worked with groups of children on the move, participated in field visits and helped children who have problems in other cities. In 2016, she conducted the MAEJT consultation on working children in Senegal.

#### Maria Loredana Campione - Volunteer, UNICEF

Maria Loredana Campione is a 16-year-old Italian student and UNICEF volunteer. She has recently been part of the Junior Summit 7, a summit fully dedicated to discussing child migration, violations of rights and exclusion. Following that, she has become a UNICEF volunteer, which has given her the chance to take part in many meetings discussing the forenamed issues, have friends in many different parts of the world, and get different points of view regarding migration, racism and inclusion – which she is more than passionate about.





#### Mariane Andrade Quintao - Participant, Campaign to End Immigration Detention of Children

Mariane is a 23-year old young adult from Brazil. After spending seven years in the U.S., she was detained and spent three weeks at a detention center in New York, which had a profound effect on her before being she was returned to Brazil, a country that she could barely remember. In 2012, she was a participant at the launch of the Campaign to End Immigration Detention of Children in Geneva. She recently graduated with a degree in international relations in Brazil and is currently working on a master's thesis about the immigration detention of children.

#### Milena Franke - Volunteer, UNICEF

Milena is a 17-year old Armenian and half-Iranian girl. She has been working for UNICEF for two years. She left her hometown, Yerevan in Armenia, when she was four years old. She recounts being very confused as to why she had to leave her hometown but her mom explained to her the reasons when she was eight years old. Currently, she is lives in Germany and is doing her A-levels. She would like to become a doctor, like her mom, or a pilot or lawyer, and to travel to Dubai. Her biggest dream is to visit Mecca one.



#### Mohamad El Safadi - Fleet and Store Manager, Solidarités International

"I am in love with cities I've never been to and people I've never met". Palestinian by blood and born in a country that doesn't recognize him as its citizen nor a resident, Mohamad Abdallah El Safadi is a refugee. He is the second-born child out of five siblings and was raised in Baddawi Camp in North Lebanon, a camp that brought him back to reality every time his desire of travelling grew. He currently works as Fleet and Store Manager for Solidarités International, an NGO that works to improve the living conditions of populations affected by the Syrian conflict.





#### Monika Chaulagain - Leader, 'We' for Change

Monika is a young girl from Nepal who, since 2013, has been leading the youth-led organization called 'We' for Change in different capacities. 'We' for Change is the only youth-led organization in Nepal that is led and executed by young people between 16 and 24 years old. Monika's major role in the organization involves decision-making, developing strategies and involving young people for safe spaces in community.

#### **Myo Thet Oo - Country Coordinator, Youth LEAD**

Myo Thet Oo is a 23-year-old, passionate youth advocate promoting child-friendly legal aid in Myanmar. He studied civil engineering and in 2010 started volunteering at a community-based organization working for people living with HIV. He currently works at a local NGO which works for and with child protection in programming and policy. He is Country Coordinator of Youth Leadership, Education, Advocacy and Development Network (Youth LEAD) in Thailand. In 2015, he was honored by International HIV/AIDS Alliance with "The Most Inspiring Youth Award". He writes on meaningful youth participation, better health coverage and on creating an enabling environment for all young people, including marginalized populations.





#### Ahmad Nadeem - Translator and Interpreter, Association for the Social Support of Youth

Ahmed works as a translator and interpreter in a shelter for unaccompanied minor asylum seekers in Makrinitsa, Volos, Greece for ARSIS-Association for the Social Support of Youth, a non-governmental organization. He also worked with Save the Children, which was collaborating with ARSIS in Kos Island, as a translator and interpreter, during the refugee crisis. He is currently attending classes at the 1st EPAL (Lyceum) in Nea Ionia, Volos.

#### Najeeba Wazefadost - Founder & President, Hazara Women of Australia

At 10 years old, Najeeba fled Afghanistan with her parents. She sought asylum from Australia by sea in September 2000. She spent several months in mandatory immigration detention before being recognised as a refugee. Arriving with no knowledge of English, by the age of 14, Najeeba had mastered it well enough to win a national essay-writing competition and start the advocacy journey. Najeeba is the founder and president of Hazara Women of Australia, helping newly arrived refugee women learn English and more quickly feel part of their new communities. She also works as a settlement case manager in Sydney and has established her own childcare business.





#### Obeid Heimaq - Volunteer with youth and children

Obeid was born in Afghanistan and fled to Germany when he was six years old. He grew up in a foster house (Haus Carl Sonnenschein). There, he went to school and developed his personality. He joined the small council in his foster house to fight for the rights of children, not only children who were without parents or had problems in being reunited with them, but also underage refugees who were on the move. Because of his involvement in volunteering, he has had many experiences and participated in many projects.

### Pinar Aksu – Advocate, Global Campaign to End Immigration Detention of Children

Pinar is originally from Turkey and has been living in Scotland for over a decade, and now has refugee status. Pinar was detained as a 14-year-old in the UK with her parents and younger sister, who was only eight at the time. She has a BA in Community Development and is now completing her masters in human rights in Glasgow, Scotland. Her own description of detention is "many dreams being locked away" and in her writing she writes honestly on the prejudices that many refugees face when they resort to immigrating.





#### Rina Kadiri - Former intern, Terre des Hommes Kosovo

Rina is a 20-year girl old from Kosovo. She was born in Munich as a refugee child and went back to Kosovo with her family after the war ended. She is studying social work and I loves this profession. She is very interested in migration, and wrote her thesis on the "Challenges of repatriated people in Kosovo". She has just finished an internship at Terre des Hommes Kosovo. Besides that, she does a lot of voluntary work, mainly helping Roma children in Kosovo.

#### Sandra Kebede - Member, UNICEF Youth Council

Sandra is an 18 year-old girl and who has just graduated high school. Her parents are both from Ethiopia; she was born and raised in Germany. She has been socially and politically active for four years. Her main focus is to spread awareness for the UN Children rights as she part of the UNICEF youth group in Frankfurt and an elected member of UNICEF Youth Council, where they discuss topics that concern young people, such as political participation. In addition, Sandra tutors a refugee from Afghanistan and supports him in navigating his everyday life.





#### Veli Ademi - Leader, UNICEF Youth Team

Veli is an 18-year old student who was born in Kosovo. Veli's parents left their home country in 1999 as refugees. Soon after their arrival Veli was born in Germany. Unfortunately, they had to leave Germany and return to Kosovo; in 2003 they fled Kosovo again. After good school results in Wesel, he enrolled at a Gesamtschule to take his A-levels. His greatest achievement yet was the founding of the UNICEF Youth Team which he is a leader of. Veli's aim for the future is to support families on the move.
